Granite, gabrodiabasite, shungite, basalt

Shungite is a natural mineral with various useful properties and is a brand for Karelia. Industrial extraction of shungite is carried out only in our republic and nowhere else in the world.

It is widely used in metallurgy (main consumer), construction, chemical industry and instrument making, used in wastewater treatment, in agriculture as fertilizers. Also, jewelry and souvenirs are made from it.

Karelian petroglyphs are one of the oldest rock carvings on Earth. They are more than 5 thousands years old.



It covers a 20.5 km long section of the Onega lake shore and includes 24 groups, including 1100 figures and signs.

The White Sea petroglyphs are located in the place of Zalavruga, on the islands of the Vyg River. A total of 39 groups were found here, including more than 2000 individual figures.





The Kizhi Museum-Reserve is one of the largest open-air museums in Russia.



Included in the UNESCO World Cultural and Natural Heritage List, it is a particularly valuable cultural heritage site of the nations of Russia.





More than 100 thousand tourists visit Valaam annually.

Conducting inspections only by agreement of the Ministry for the Development of the Russian Far East and in a shorter time frame

Provision of land plots in state or municipal ownership, without bidding

28 The work of checkpoints in the Arctic zone of the Russian Federation

Checkpoints on the state border of the Russian F with special rules.



In the implementation of customs and other types of control, the 'one window' mechanism is implemented.



Sanitary-quarantine, veterinary and phytosanitary quarantine control (supervision) of goods and vehicles at state border checkpoints located in the Russian Arctic is carried out by customs authorities.

Checkpoints on the state border of the Russian Federation in the Russian Arctic operate in accordance



The work of the state control authorities at the checkpoints of the Arctic zone is carried out around the clock.



The documents required for the implementation of control measures (with the exception of identity documents) may be submitted to the customs authority in e-form.



A resident of the Russian Arctic has the right to apply the procedure of a free customs zone (FTZ). This measure is aimed at entrepreneurs interested in exporting products and using imported equipment.



Russian goods are placed and used with the payment of excite duty and without payment of export customs duties.



STZ can be created on the equipped sites of residents of the Arctic zone.



Foreign goods are placed and used without paying customs duties and VAT.



30 Benefits for residents of the Arctic zone of the Russian Federation

Free of customs duties and VAT

The use of imported equipment and components for production purposes on the territory of the land.

The use of imported components in assembly production during the subsequent export of goods.

Payment of duties either for individual components or for the whole product.

The use of imported components in the assembly of imported components in the production of subsequent sales of goods in the territory of the Customs Union.



Criteria for Applicants for Resident Status of the Arctic zone 31

- Individual entrepreneur or legal entity
- Registration on the territory of the Arctic zone of the Russian Federation
- The minimum amount of capital investments in an investment project must be at least 1 million rubles (excluding VAT)
- The investment project or line of business must be new to the applicant at the time of application

A new project is a project in which, at the time of filing an application, the volume of capital investments made during the implementation of an investment project does not exceed 25% of the total investment provided for by the business plan.

- Lack of the status of a participant of a regional investment project.
- The applicant should not be in the process of reorganization, liquidation, bankruptcy.
- No arrears in taxes and fees, insurance premiums

Current list of support measures for investors 33

- Provision of land plots to businesses without bidding
- Lease payment for the use of land plots 0.01% of the cadastral value of the plot
- Preferential conditions for the purchase of land plots for business activities
- Tax incentives: exemption from corporate property tax and a reduction in the income tax rate
- Investment deduction for corporate income tax
- Assistance in providing loans at a rate from 1% per annum

Subsidies from the budget of the 34 Republic of Karelia for partial compensation of costs

- To pay interest on loans in the amount of the key rate of the Central Bank of the Russian Federation + 2%
- For construction (reconstruction) and (or) acquisition for own needs of buildings, structures, objects of unfinished construction — up to 90%
- For the purchase of machinery and equipment up to 90%
- To create the infrastructure necessary for the implementation of investment projects
